This Change Order provides contracting officer direction to implement the partnered government decision package reductions for Fire and Security at the North CCAFS (ITL) Area. You are hereby directed to implement a reduction in these services effective 15 Sep 06. The security changes in the ITL area include terminating the 2 Member Security Response Team and the SMAB Internal Response Force and one vehicle. A reduction for Fire Station # 3 requirements (ITL area) are also to be implemented. Technical Exhibit 3.1.2.03, Baseline Realignment Security Posture FY04-08 and SOW changes for WBS 3.1.1.1 and 3.1.1.11 was provided to SGS to reflect the above requirement changes.  
This Change Order will be definitized as part of the Atlas/Titan proposal negotiations. A Decision Package notification letter dated 7 Aug 06 indicated the government's intent to take this action. Definitization of this change order will occur not later than 30 Nov 06. (Note: Severance costs, if any, should be identified and will be costed in FY06)
